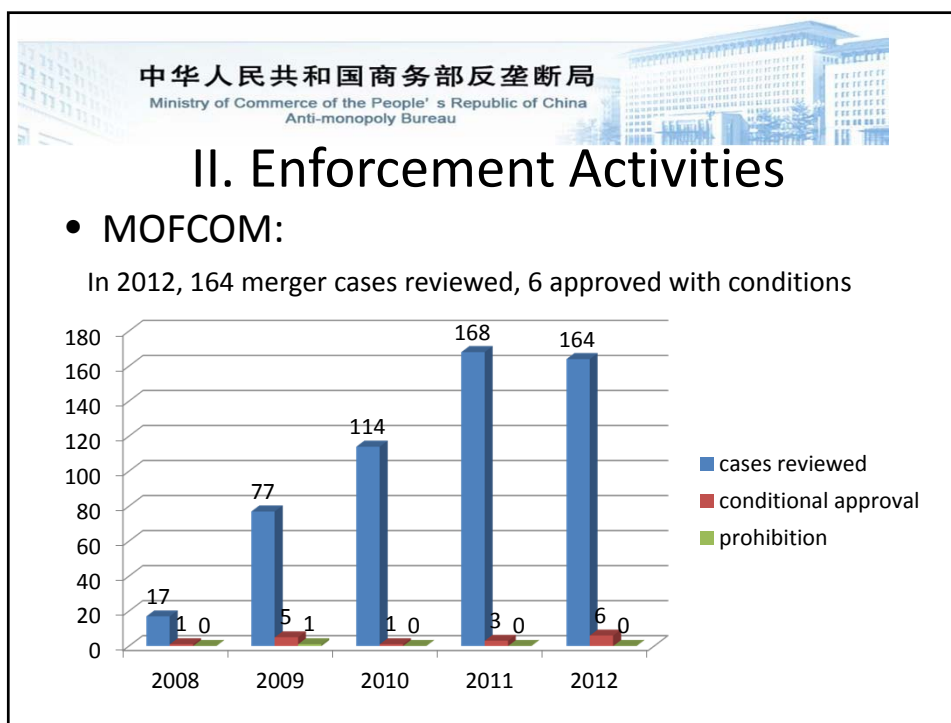

## Cartel and Abuse of Dominance cases

- **NDRC:**
  - Samsung, LG and 4 Taiwan LCD manufacturers Chimei, AUO, CPT, Hannstar
    - 2001-2006, cartels among 6 LCD manufacturers
    - Price Law, Refund, confiscation and fine totalled 353 Mio RMB
- **SAIC:**
  - Since 2008, 18 cases investigated by provincial authorities under authorisation of SAIC, 17 cartels cases, 1 abuse of dominance case
  - Covering sectors including construction materials, second-hand autos, insurance, telecom, etc.
