

The highest decision making in the KPPU is the **COMMISSIONER MEETING**. The Commissioners are selected through political process by the Parliament and the President and assigned for five years term of office. The Presidential Decree on the late 2012, appointed 9 (nine) Commissioners of KPPU for the term office until late 2017. The Chairperson and Vice Chairperson are selected among the Commissioners for the agreed time. Now, the Chairperson and Vice Chairperson are appointed for two and half year. Based on the meeting of Board of Commissioners, Mr. Muhammad Nawir Messi and Mrs. Saidah Sakwan are appointed to lead the Commission until July 2015. In addition to the Chair and Vice Chairperson, the Board of Commissioners also introduces new approach in the leadership, including by dedicating each Commissioner to specific roles agreed amongst them.
